		<p>No Competitor to load their bow until they are standing astride the Shooting line until cleared to do so.</p> <p>There shall be no deliberate high or wide shooting. All spectators to stay behind safety lines. Competitors to wait until instructed to collect arrows from the target</p> <p>Range Set up and Layout to facilitate positioning of targets, shooting lines with corresponding shooting directions and loci to avoid: Facilities. Registration, toilets, , waiting areas, pathways, rights of way.
